









If you work at, attend, or your child attends our school, what data sources are being used to determine the impact of lost instructional time for students?





People tended to spend time in Mexico.


Students from these groups tended to fall behind their classmates not in these groups.

In my opinion, the area that suffered the greatest gap in learning was reading. It is important that SCISD find a way to address this situation. As a middle school teacher, I am frequently required to read tests to between 1/5 and 1/4 of students in my grade due to dyslexia issues. This situation could be more directly addressed in the early grades by employing a full-time reading specialist before student learning relies so heavily on being able to read.
